

JPIAMR 13th Joint Call: One Health interventions to prevent or reduce the development and transmission of AMR

Q&A Online Webinar for applicants 28 January 2021

This is a selection of questions and answers from the global webinar that invited researchers to learn more about the call and to ask questions to representatives from funders participating in the call. Q: What is JPIAMR definition for "transmission" and "intervention"?

A: Definitions for "transmission" and "intervention" are available in the <u>JPIAMR Strategic</u> <u>Research and Innovation Agenda</u>.

Q: What is the definition of a partner? A legal entity?

A: A partner is a research group participating in a project.

Q: Are two organisations in the same country two partners or one partner, since it is the same country?

A: Two organisations in the same country are generally considered as two separate partners. However, please consult your funding organisation since particular rules may apply.

Q: Is it required to have a Swedish partner in the consortium, if an LMIC partner requests funding through Sida?

A: No Swedish partner is required if an LMIC partner requests funding from Sida.

Q: We need two EU partners/EU associated partners to be eligible according to the call text. Is a lab coming from UK considered as an EU/EU-associated partner?

A: UK is considered as an associated EU country. In this call, the same rules will apply to EU and EU-associated partners regarding the composition of your consortium.

Q: I am from a UK university. Is there a UK contact point?

A: Please find funders details and contacts in the call text (annex B)

Q: Can we have two partners from the same country, or even three?

A: The number of partners from the same country is part of the national rules. You have to check this with the respective funding agency, please find funders details and contacts in the call text (annex B).

Q: For the SIDA grant, is it limited to two partner institutions from the Sub-Saharan African countries?

A: A maximum of two partners in one consortium can apply for Sida-funding.

Q: How can we find a partner?

A: Please use the Partner Search Tool: https://ncn.gov.pl/partners/amr13th

Q: Can a partner from an LMIC be the lead coordinator for the project?

A: Yes, LMIC partner can be a coordinator if they are eligible for funding.

Q: Would an intervention study that is taking place in Indonesia with collaborators in the UK and Australia be eligible for this call?

A: You need at least two EU Countries funded by the JPIAMR Consortium thus your consortium is not eligible.

Q. Is there a budget cap by project or by country?

A: Max requested budget depends on the national funding organisation.

Q. I am from Greece, and there is no participating agency /organisation listed in the call. Does this mean there is no budget or is the only way to participate as a funded partner to partner with another country?

A: You can only participate as a non-funded partner (meaning that you cannot request funding) since Greece does not participate in the call. You cannot be a project coordinator for this call.

Q: If the project involves two European countries and one LMIC, must it be the same intervention tested in all settings?

A: Each project should address at least two One Health settings to be eligible. However, it is not necessary to apply the same intervention to both settings.

Q: Can a company submit an application on their own? Or, must the application come from an approved research institute?

A: A company can join a consortium, however an application by one institution only is not eligible. Please check with your own funding organisation if your company is eligible for funding.

Q: Are SMEs funded or RPOs only?

A: Eligibility of SME or RPO depends on national rules.

Q: What is the latest start date possible of a project?

A: Projects must start before July 2022. Please note that some funding organisations may have additional constraints. Thus, check the latest starting date possible with the different funding organisations involved in your project.

Q: Can an already funded partner in previous JPIAMR be funded in the JPIAMR 2021?

A: Generally yes, please check the national rules for any exclusions.

Q: Can a consortium composed by 4 partners coming from UK, Sweden, Jordan and Bangladesh, be eligible for applying?

A: Yes, this consortium is eligible if each partner is eligible for funding. Indeed, in this example, UK and Sweden are two EU/EU associated participating countries and Jordan and Bangladesh belong to LMICs.

Q: Is it possible for a partner working in Cameroon to apply?

A: Cameroon partners can be funded by ICARS/SIDA. Please check your eligibility directly with those funding organisations. Please note that a consortium cannot be composed by partners

coming from the same country. Consult the call text for the requirements concerning the composition of your consortium.

Q: Is it possible for a partner working in Liberia/ Ethiopia to apply?

A: Following the <u>OECD DAC List</u>, Liberia and Ethiopia are considered as a least developed country. Please check your eligibility directly with ICARS and SIDA.

Q: Can Brazil be funded by ICARS?

A: All LMIC countries are in principle eligible for ICARS funding. Please consult the annex B of the call text for additional requirements and contact ICARS to check the details regarding your eligibility.
